ENTRY GUIDELINES

- Entrants must be at least 18 yrs. old and a resident of Thurston, Mason, Pierce, Lewis, Grays Harbor, Pacific, Kitsap, Clallam, Cowlitz, Skamania, Wahkiakum, or Jefferson counties, Washington.
- Up to 3 entries per artist. Fee: \$20 for OAL members & students with ID, others \$25.
- 2-D work cannot be more than 48" in either dimension, and not less than 10" in either dimension.
- 3-D work (sculpture), maximum size 3 ft wide x 6 ft high. Sculptors with heavy work must assist with its handling.
- Hanging art must be sturdily framed and wired for hanging. (No saw-tooth hangers, scratched or damaged frames, or "clip" frames.)
- All artwork must be original, must have been created within the past two years, and must be solely the work of the applicant. No instructor-assisted art is eligible.
- Artists will be responsible for hand-delivery and pick-up of their art at the Minnaert Center for the Arts at specified dates and times, no exceptions.
- All art entered must be for sale and must remain until the end of show.
- No price changes or substitutions of work after registration.
- SPSCC will handle sales. Sales commission to SPSCC Minneart Center is 15%. Checks will be mailed to artists at end of show.
- Images of your work to be submitted on a CD. JPG format, not more than 600 pixels on the longest side, @72 ppi resolution. Write your name on the CD, and the names and medium of your pieces. (Please call Ruth Roberts [866-7150] if you need help with this.)

JUROR *Barbarba Benedetti Newton will judge this show. She has a long list of awards and honors for her beautiful colored pencil and pastel work, and has taught classes and authored a number of books and articles on both media. Newton is an active member of Women Painters of Washington, and several other art organizations. She is represented by Jeffrey Moose Gallery in Seattle, State of the Arts Gallery in Olympia, and The Attic Gallery in Portland.
