ENTRY GUIDELINES

- Entrants must be at least 18 yrs. old and a resident of either Thurston, Mason, Pierce, Lewis, Grays Harbor, Pacific, Kitsap, Clallam, Cowlitz, Skamania, Wahkiakum, OR Jefferson Counties, in Washington State.
- Up to 3 entries per artist but **only 2 can be chosen for show**. Fee: \$25.00 for OAL members & students *with ID*; Non-OAL members, \$30.00.
- 2-D work cannot be more than 36" in either dimension and not less than 10" in either dimension. NO 3-D work accepted *including* hanging clay art
- 2-D hanging art must be sturdily framed & wired for hanging. (**No** saw-tooth hangers, scratched or damaged frames *or "clip" frames*.) If improperly framed, work will NOT be accepted.
- All artwork must be original, **must** have been created within the past two years, and must be solely the work of the applicant. **No instructor-assisted art is eligible.**
- Artists will be responsible for hand-delivery and pick-up of artwork at Olympics West on the specified dates and times listed above.
- All art entered must be for sale and must remain on display until the end of the show.
- No price changes or work substitutions can be made after registration.
- Olympics West will give interested buyers the artist name & phone number. No other contact information will be released.
- Images of your work must to be submitted on a CD. **Instructions:** JPG format, not more than 600 pixels on the longest side, @72 ppi resolution. Write your name directly on the CD plus all titles, type of medium, price, phone number & email.
